## Gonic Elementary School Asbestos Abatement Project Scope of Work Rochester School District

The successful general Contractor will provide all necessary services for the safe abatement of asbestos containing building material (ACBM) in the exposed textured ceiling of the Gonic Elementary School first and second floors comprising approximately 4,500 square feet. The work will be bid as two separate projects, one for the first floor and another for the second floor. Each project will be awarded separately based on the availability of funds. The scope of work includes but is not limited to:

- Removal of existing ACBM ceiling mounted electric lighting.
- Removal of existing ACBM ceiling mounted fire suppression system.
- Removal of existing ACBM ceiling mounted fire alarm system.
- Removal of existing insulation above second floor ceiling.
- Removal of existing ACBM ceiling mounted HVAC duct.
- Abatement of ACBM ceiling.
- Installation of a new suspended ceiling system.
- Installation of new insulation where removed.
- Reconfiguration and reinstallation of all mechanical and electrical systems at new ceiling elevation.
- All work to be properly permitted and performed only by personal authorized and/or licensed in the State of New Hampshire to perform such work and adhere to work practices and procedures set forth in applicable codes, regulations, and standards related to work.
- The Contractor shall assume full responsibility and liability for compliance with all applicable Federal. State, and local regulations pertaining to work practices, hauling, disposal, and protection of workers, visitors to the site, and persons occupying areas adjacent to the site.
- The Contractor will provide a Certificate of General Liability not less than \$1,000,000 and a Performance Bond equal to 100% of the construction value.
- The Contractor will work in conjunction with Rochester School District's Industrial Hygiene Consultant, RPF Environmental, Kara Forsythe, 888-SAFE-AIR, EXT 18.
- This project is subject to the availability of funding.
- No work shall commence prior to the July 10, 2020, and all work must be complete prior to August 28, 2020.
